

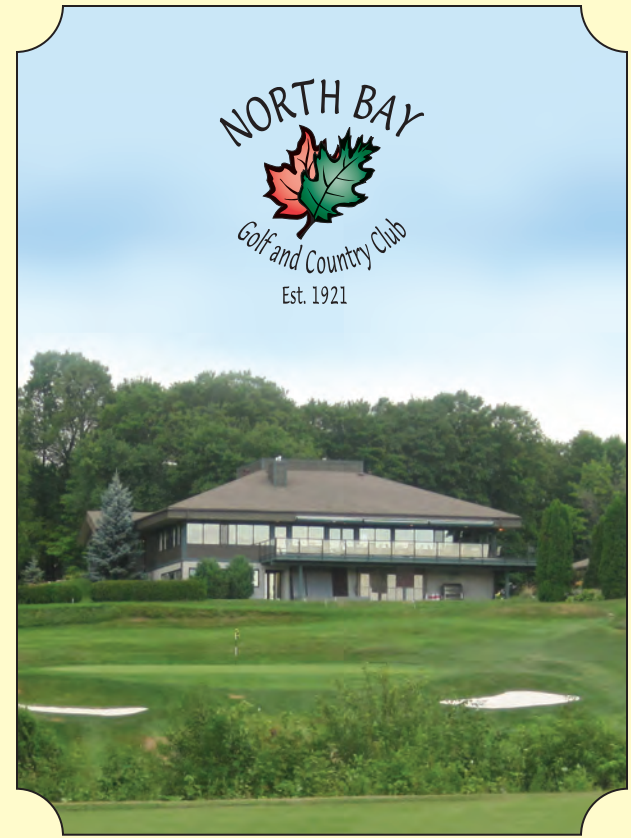

Each Member will have immediate access to their monthly account statement via the TEE ON management POS system. These statements will indicate all transactions for purchases from the Pro Shop and Food and Beverage areas of the North Bay Golf and Country Club. There will be a 2% interest charge per month (24% per annum) calculated from the due date until the full payment is received.
